The post of State Commissioner for Persons with Disabilities is lying vacant since 20.08.2022 on cessation of the term of the present incumbent.

Applications are invited for selection to the post of state Commissioner for Persons with Disabilities (SCPD) as prescribed under Chapter-VII of Odisha Rights of Persons with Disabilities Rules, 2018 read with Odisha Rights of Persons with Disabilities (Amendment) Rules, 2021 for a period of three years from the date of assumption of office or till he/she attains the age of 63 years, whichever is earlier.

Functions of the State Commissioner

The SCPD shall function as per provisions of section 80 under Chapter-XII of Rights of Persons with Disabilities Act, 2016 and as provided under the afore mentioned rules

Eligibility Criteria

In order to be eligible for appointment as Commissioner, a person must:

- Be below sixty years of age as on dt.01.01.2023.
- Possess the following qualification and experience, namely: -
 - i. Be a Graduate from a recognized University.
 - ii. Preference shall be given to persons having recognized degree or diploma in social work or law or management or human rights or rehabilitation or education of Persons with Disabilities.
 - iii. Have an experience of at least twenty years in a Group "A" level post in the Central Government or a State Government or a public sector undertaking or a semi-Government organizations, or an autonomous body dealing with disability-related matters or social sector or as a senior level functionary in registered national and international voluntary organizations in the field of disability or social development. Provided that out of the total of twenty years of experience, he/ she shall have at least three years of experience in the field of rehabilitation or empowerment of persons with disabilities.

Selection Procedure

All applications will be examined by a Search-cum-Selection Committee. The Committee shall recommend to Government a panel of three suitable candidates for the post of Commissioner from amongst all eligible applicants.

Honorarium

The salary and allowances admissible to the State Commissioner shall be the salary and allowances admissible to the Additional Secretary to State Government.

Documents to be submitted with application.

- Self-attested copies of Educational Certificates.
- Self attested copy of HSC Certificate (in support of date of birth)
- Self attested copies of certificates (As proof of experience claimed by the applicant)
 - Two recent passport size photographs.


Last date of submission of application

- Complete application along with required documents must reach the office of Principal Secretary to Government, Social Security and Empowerment of Persons with Disabilities Department by **dt 28.08.2023** by post or in person.
- Application received after the due date shall be rejected.
- Persons who have applied for appointment as SCPD pursuant to this Department earlier Advt. No 9259 dated 09.12.2022 need not apply again.
